CONSENT TO ALLOW CHILD UNDER 17 YEARS OF AGE TO PARTICIPATE IN SKATEBOARDING AND INLINE SKATING AT UPCHURCH PARK

PLEASE READ THIS DOCUMENT IN ITS ENTIRETY BEFORE SIGNING.

Section 316.0085, Florida Statutes, requires that a child under the age of 17 may not engage in the skateboarding and inline skating activities available at Upchurch Park until the City of St. Augustine has obtained written consent from the child's parent or legal guardian.

The same statute provides that the City of St. Augustine is not liable to any person who voluntarily participates in skateboarding and inline skating activities for any damage or injury to property or persons which arise out of a person's participation in such activity and which takes place in an area designated for such activity. The statute also provides that any person who participates in, assists in or observes skateboarding or inline skating activities assumes all known and unknown risks inherent in these activities irrespective of age and is legally responsible for all damages, injury or death to himself or herself or to other persons or property which result from such activities.

The City of St. Augustine is not required to eliminate, alter or control the risks inherent in these activities.

While engaged in skateboarding or inline skating at Upchurch Park, the participant must do all of the following:

1. Act within the limits of his or her ability and the purpose and design of the equipment used.
2. Maintain control of his or her person and the equipment used.
3. Refrain from acting in any manner which may cause or contribute to death or injury of himself, herself or other persons.
4. Always wear a helmet approved for skateboarding or inline skating while participating in these activities.
5. Always follow all posted rules for participation in skateboarding or inline skating activities.

By execution of this Consent, you as the parent or legal guardian of the identified child hereby consents to allow that child to participate in skateboarding and inline skating activities at Upchurch Park in the City of St. Augustine.
