■ WATER TREATMENT PLANT

- PLACED NEW 2-MGD LOW PRESSURE OSMOSIS TREATMENT PLANT INTO OPERATION
- TREATED AND DISTRIBUTED IN EXCESS OF 1.0 BILLION GALLONS OF WATER



UTILITY FUND

■ WASTEWATER TREATMENT PLANT

- TREATED 1.54 BILLION GALLONS OF WASTEWATER AND RE-USED 63.5 MILLION GALLONS OF THIS FOR IRRIGATION, TRUCK WASHING, ETC.
- REPLACED # 1 PLANT SERVICE PUMP WITH UPGRADED 25 HP SERVICE PUMP

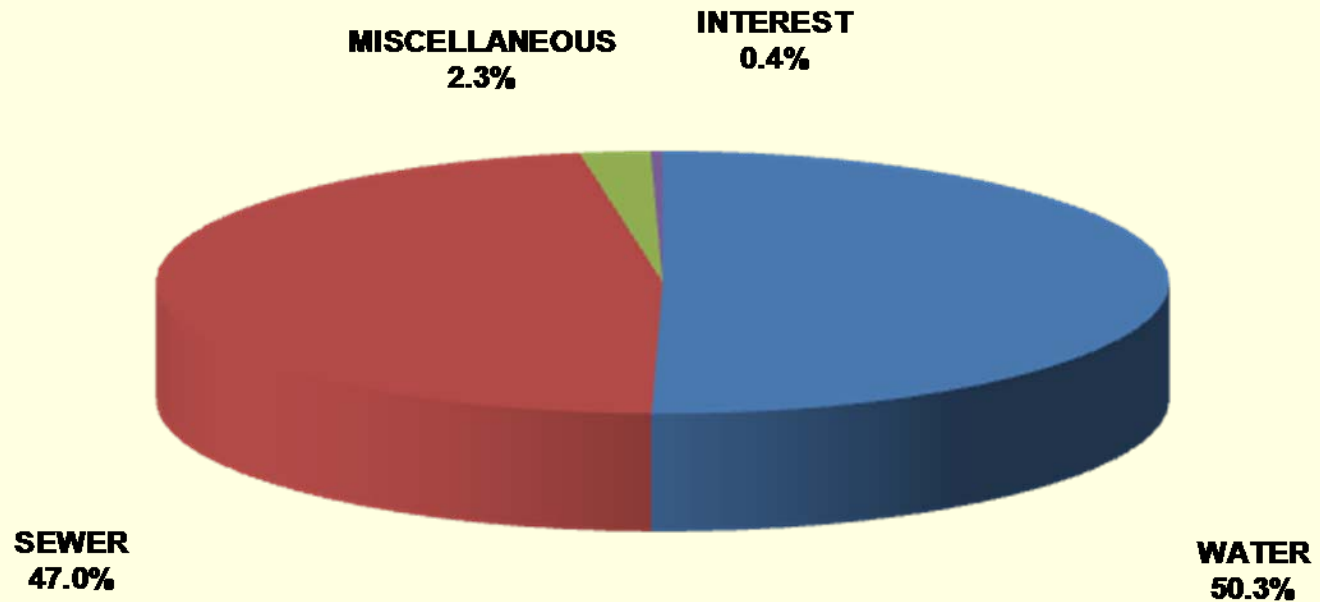
■ FY 2008-09 ACTIVITIES

- INSTALLED 2344 LINEAL FEET OF WATER MAINS AND SERVICE LINES
- REPLACED OR INSTALLED 1309 LINEAL FEET OF SEWER LINES

- ADDED FOUR NEW PUMP STATIONS



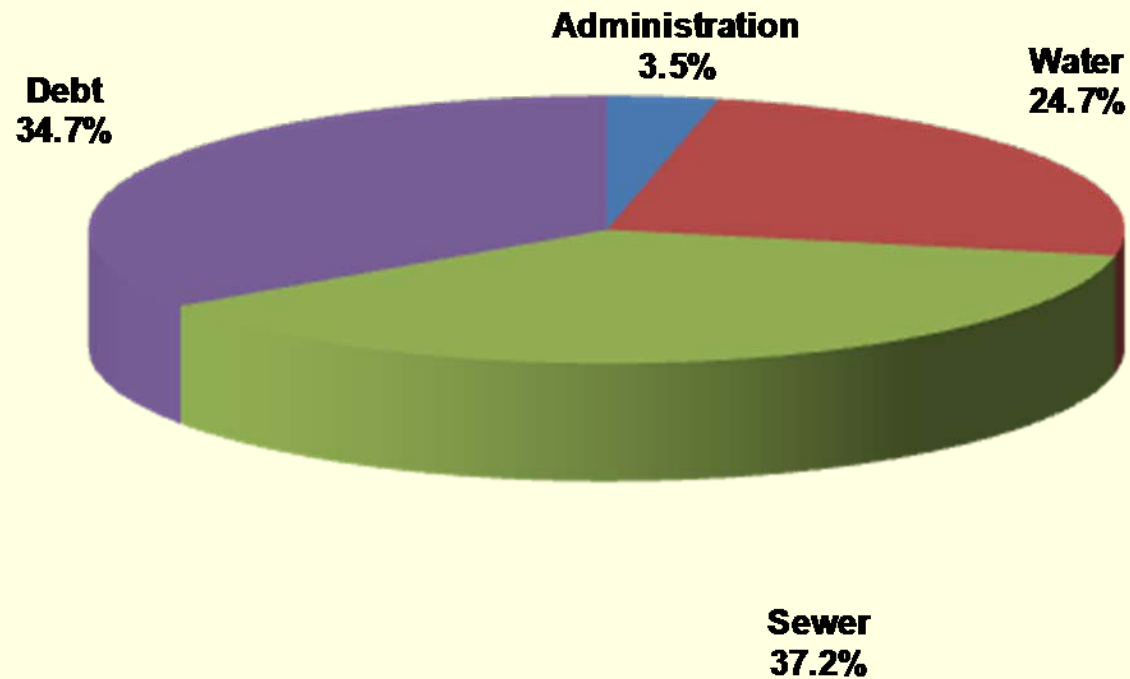

Proposed Revenue Sources--Utility



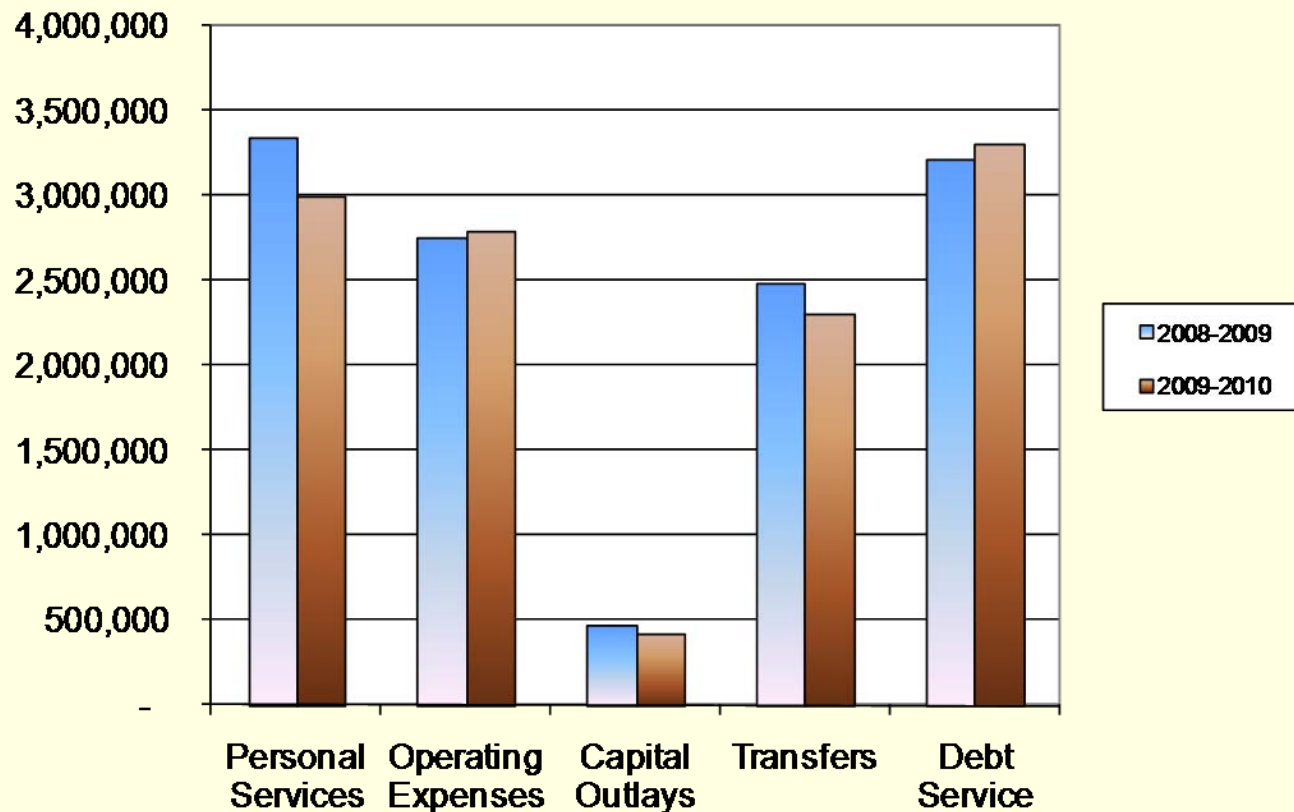

Proposed Expense Categories--Utility



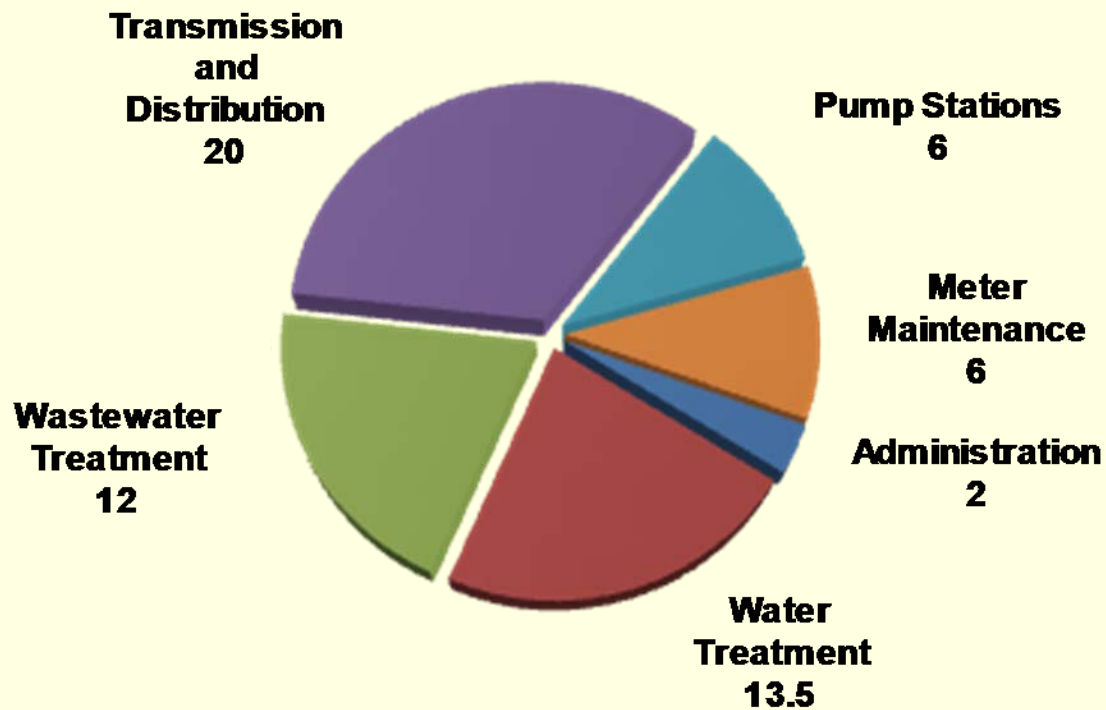

Budget Comparison by Expenditure Types

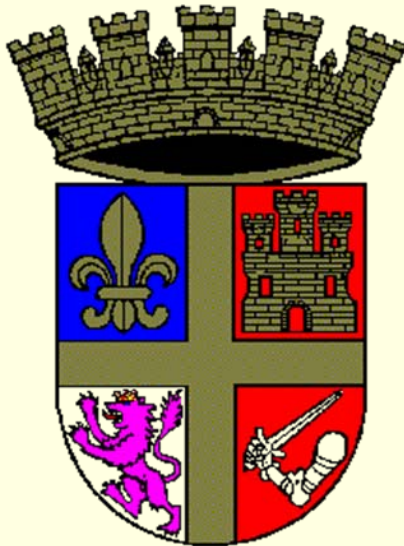

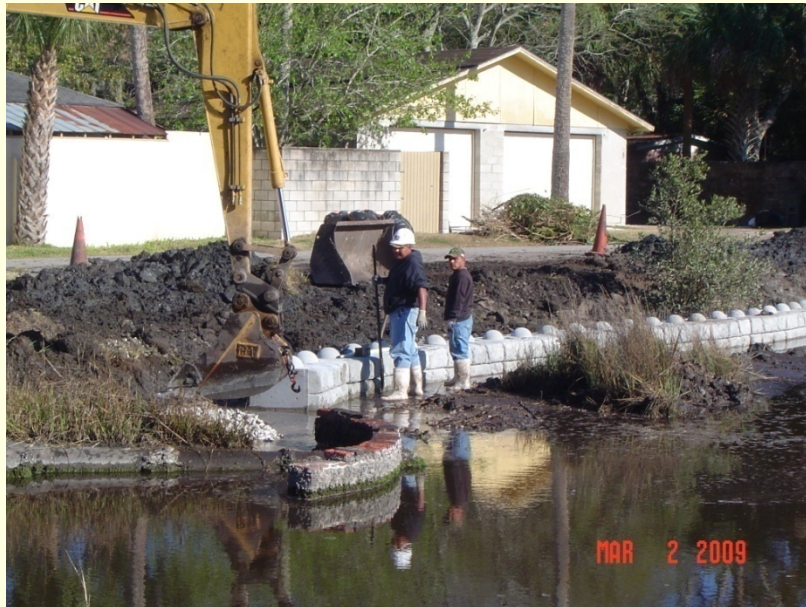

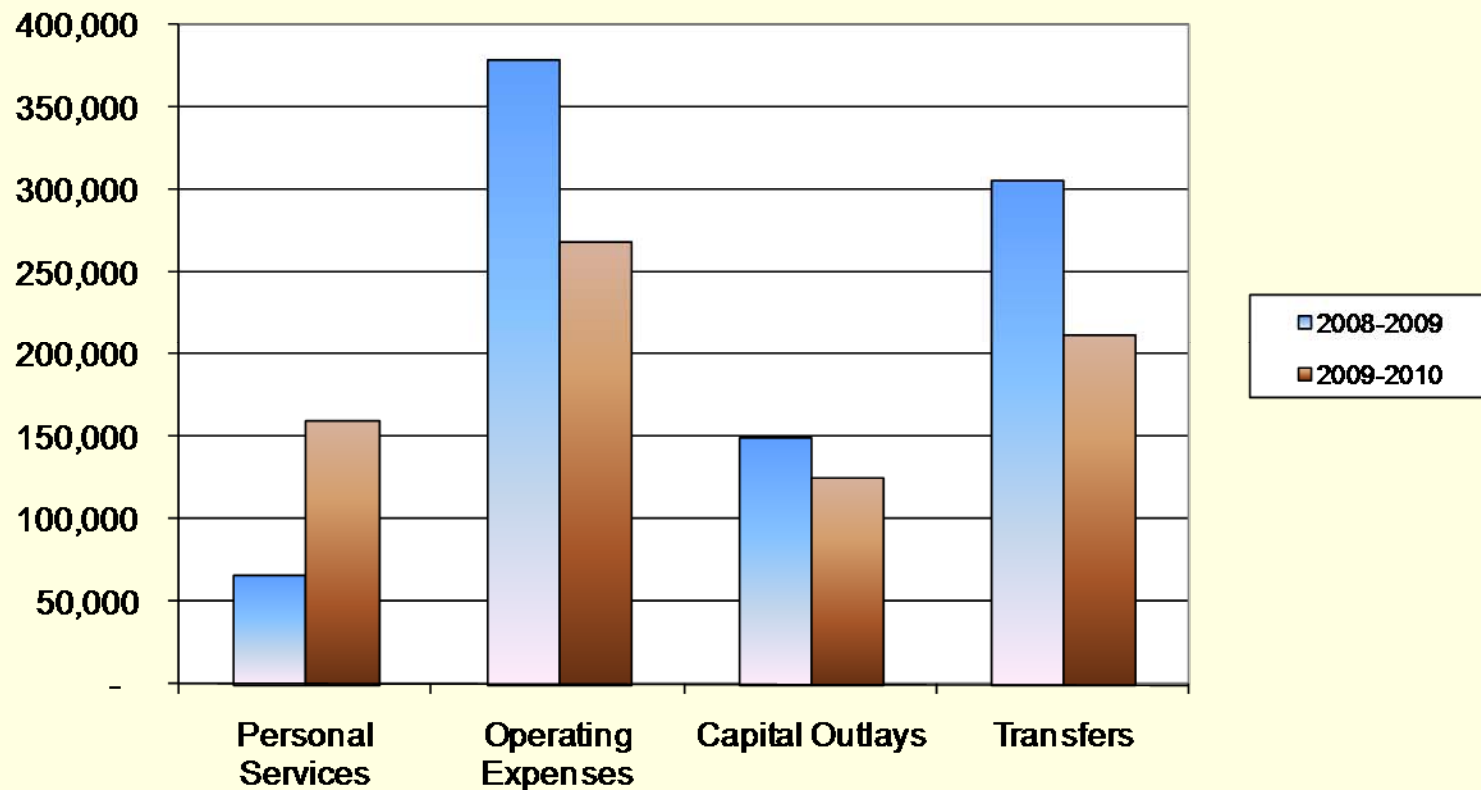

- INSTITUTED NUMEROUS EDUCATIONAL & TRAINING TOOLS FOR STAFF & CONTRACTORS

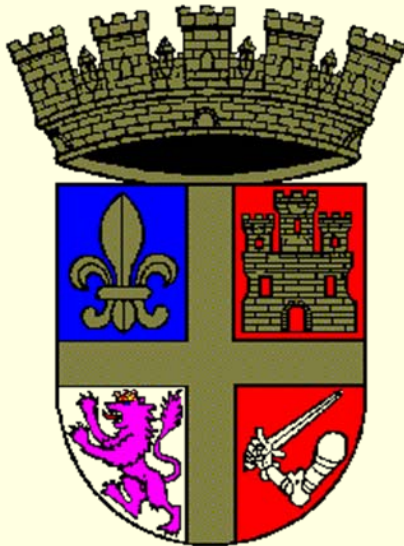

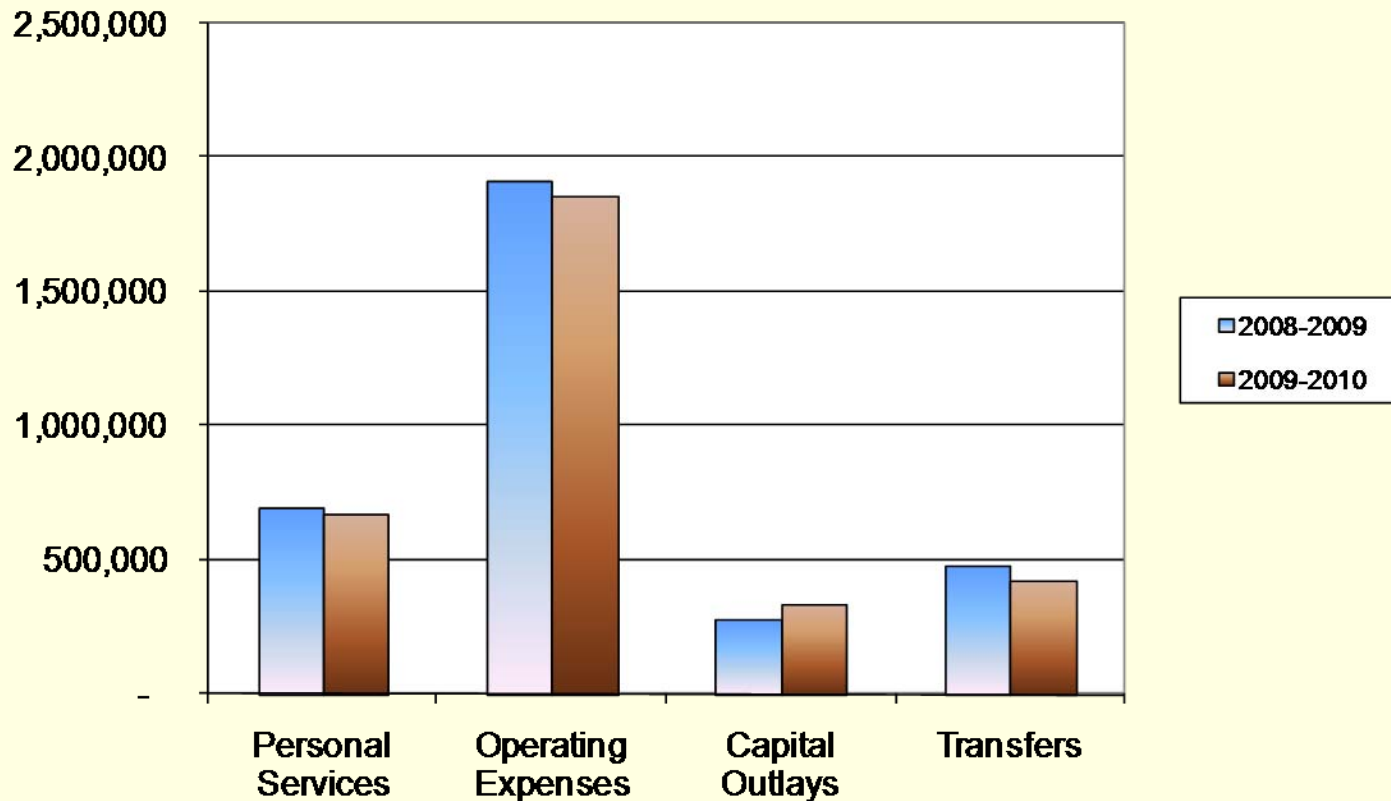
■ FY 2008-09 ACTIVITIES

- NEGOTIATED YARD WASTE DISPOSAL TIPPING FEES FROM \$28.50 TO \$15.00 PER TON

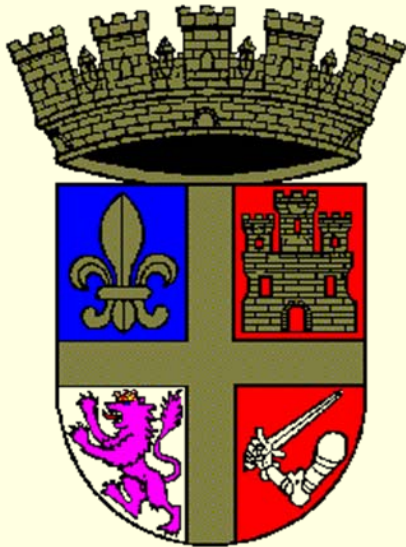
