



CONSTRUCTION PROJECT INFORMATION FLYER CITY OF ST. AUGUSTINE

Project Goal: San Marco Avenue (A1A) Watermain Replacement

Replace 6,000 feet of 10-inch cast iron main on San Marco Ave. between Cincinnati Ave. and Picolata St. This section of pipeline was a source of color and sediment in the northern portions of St. Augustine and suffered frequent breaks and will be replaced with 12-inch high density polyethylene (HDPE) pipe. Pipe bursting technology (trenchless) will be utilized to reduce outages and interruptions.

Project Improvements

Killebrew, Inc. and crews will be furnishing and installing the following items:

- 6,000 lineal feet of 12-inch HDPE Water main
- New water service to 31 Businesses, 1 Church, 1 Hotel and 2 Multi-family properties
- Benefiting over 1,000 customers

Note: Project is to upgrade water mains and services using trenchless technology to minimize interruptions in customer service and traffic flow. Project schedule is coordinated with the Florida Department of Transportation (FDOT) to be completed prior to the scheduled 2018 resurfacing project on San Marco Ave. (A1A) and in close coordination with the May Street/West San Carlos roadway improvements.

Project Overview: During the construction phase, the contractor will make every effort to provide access to resident's entrances to driveways, subdivisions and businesses during the day. At the end of each weekday, the excavation areas will be backfilled and compacted; and all residential and business driveways should be accessible. The contractor will be videotaping the entire project area prior to starting the construction to verify the existing conditions. The contractor may also be contacting property owners to identify any irrigation systems located within the construction areas. Any damage caused by construction will be repaired by the contractor at no cost to the owner.


