This project will include water and sewer improvements along Pearl Street, North Brevard Street, North Orange Street, Bruen Street, and John Street. Existing septic tank systems are to be abandoned as well as existing lateral connections and existing private grinder pump assemblies, electrical components, level controls, and tanks. The work includes restoration of asphalt paving by milling and resurfacing. This will include work on private property to abandon septic tanks, recon-figure private plumbing, and connect residents to the new sewer infrastructure.
