




What can OpenGov do for our Vendors:

- Receive notifications of future solicitation by registering on the e-Procurement Portal and selecting the “Subscribe” button to create an account.
- Follow existing opportunities and receive updates by finding the solicitation and clicking the “Follow” button. This will allow all interested Respondents to receive addendums automatically,
- Submit questions and receive timely answers online regarding open solicitations.
- Use a guided process of responding electronically to solicitations to ensure responses are accurately completed.
- One location for all solicitations issued by the City of St. Augustine.
